
## Russian Cellular Market Watch March 2003





**<u>Statistics</u>**: In March, the number of cellular subscribers in Russia (GSM, TDMA/DAMPS, NMT, IS-95, IMT-MC-450) reached more than **<u>21.3 million</u>**. The share of the regions, including St. Petersburg and Leningrad Oblast, continues to grow – now 63%.

**Additions:** In March, subscriber growth was 5%<sup>1</sup>. The overall penetration in Russia reached 14.8% of the population. VimpelCom demonstrated the highest subscriber growth in the regions. MTS is a leader in additions in the Moscow License Area. The significant growth of MTS' subscribers in the MLA is due not only to the pre-paid JEANS offering, but also to mass connections to the new tariff group, Optima.



**Regional Snapshot:** Siberian Region with its current population of 17.6 million witnessed significant growth in 2002. The overall penetration in the region rose from 2% in 2001 to 5.7% in 2002. By the end of March 2003, the penetration level reached 7.2%.
